Ombudsman's bid to join suit opposed

Two judges have asked the court to reject the Commission on Administrative Justice's attempt to be enjoined in a suit, where they are challenging attempts to retire

Supreme Court judge Philip Tonui and High Court's Justice David Onyancha want the court to dismiss an application by the commission, also known as Office of the Ombudsman to be enjoined in the matter, saying it disadvantages them.

The two want the Judicial Service Commission stopped from removing them from office. Through their defense lawyers Fred Ngatia and Pheroze Nowrojee, the judges pointed that the involvement of the Ombudsman will tip the level playing field. There are three similar matters before the court. Ombudsman has not made an identical participation with the other two but desires participation in this one, Ngatia told judge Justice George Odunga. Nowrojee said Ombudsman had not given the court any specific reason to intervene. But the Ombudsman said whatever opinion they would table would not be binding to the court. Ruling is on November 3.

Koinange's widow testifies in murder case

Eddah Wanjiru defends herself, says powerful people in Government killed a land activist

Former powerful Cabinet minister Mbiyu Koinange's widow Eddah Wanjiru has testified in court that powerful people in Government killed Maasai land rights activist Moses Mpoe. Ms Wanjiru, who is facing twin

murder charges with six others including her step son, defended herself yesterday in the presence of their law-yer Paul Muite before Nakuru High Court judge Hellen Omondi, saying powerful people killed Mpoe.

She said Mpoe was killed for opposing the resettlement of Internally Displaced Persons at the centre of a controversial 4,923-acre farm in Mau Narok owned by her family. "I had employed Mpoe in my farm and could

not have killed him as I had a good re-lationship with him," she said. Wanjiru said there were rumours against her and her co-administraagainst her and her co-administrator in the farm David Njuno, who is among the accused in the case. The late Cabinet minister's widow said the rumours emerged after their objection to sell the farm to then Juja MP William Kabogo.

Wanjiru, Njuno and five other people, Nicholas Ngetich, Johnstone Sigei, Stephen Mwanga, Sanaga Mbukoi and Kiragu Macharia are on trial

koi and Kiragu Macharia are on trial for allegedly killing Mpoe and another man, Parsaaiyia ole Kitu on December 3, 2010 in Nakuru

She further told the court that since 2009 to Mpoe's death in December 2010, he had called her many times to say he was fearing for his life. "When I first heard news of his death, I felt so bad. I remembered the many times he had called to say people in Government wanted him dead because he was opposing the sale of our farm," she testified.

She noted that during her business trip to China in November 2010, Kabogo prevailed upon beneficiaries

of the estate led by David Waiganjo to sack Mpoe against her wishes

Wanjiru further informed the court there was a scheme by Kabogo to acquire the land despite objections from part of the administrators of the late Mbiyu's estate.

She said an agreement of Sh214

I remembered the many times he had called to say people in Government wanted him dead because he was opposing sale of our farm million to purchase the property was reached and Kabogo paid a Sh21 million deposit and gave them a guarantee of Charter Bank, which closed its business about 24 hours later.

According to her, they discovered within the 24 hours that Kabogo had transferred the farm's title to his company despite a debt of Sh193 million. We moved to court immediately but

the case is still pending," said Wanjiru.

Mpoe and a fellow passenger were
shot dead by a gunman riding on a
motorcycle at Soilo Junction on the Nakuru- Eldoret Highway. At the time of his killing, he was leading a cam-paign seeking to repossess thousands of acres of land allegedly taken away from the Maasai community by colonialists. Hearing of the defence case continues today.

Woman sues German Embassy over photo in tourism promotion

A Samburu woman is demanding compensation from the German Embassy over a photograph that was used to advertise Lake Turkana Fes-

The 32-year-old woman, who filed a case in the High Court through her lawyer Ham Lagat, claims the picture was used without her consent. Worse still, she said her husband kicked her out of her home upon learning of the

Telaso Lepalat told the court the use of her photograph to advertise the event infringed on her private life and the right to make a choice as to whether she wanted her photo in the advert. petitioner is constrained to make this humble petition on the main reason that there were human rights violations that occurred to her during 2012 to-date, when the respondent unlawfully procured her photograph without her consent," the petition read in part.

She said the event dubbed Lake Turkana Festival and held in Loiyangalani, Marsabit County, was commercial in nature. The photograph is said to have been used in Habari Magazine, which is allegedly owned by the Embassy.

In the case where Attorney General Githu Muigai is an interested party, the court heard that the embassy pulled out the photo after the woman issued them with a demand letter on April 28 this year.

SAMBURU CUSTOMS
